**Sub. : Guidelines for filling of vacant seats for M.E. / M.Pharm. courses at institute level(SFI) for the year 2014-15**  
**Ref. : Rule- 20 of Education Dept., Govt. of Gujarat Notification No. : GH/SH/37/2013/PVS/102013/404/S dt. 26-6-2013**

With reference to Rule-20 of above referred notification, it is hereby informed that after completion of admission process, if the seats remain vacant, such vacant seats are to be filled at institute level. The details of such vacant seats after Round-2 is available on website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in). Accordingly it is hereby informed to fill vacant seats at institute level as per following rules and guidelines.

1. Applications are to be invited for vacant seats by giving wide publicity in form of advertisement in daily newspaper having wide coverage in state of Gujarat or other suitable means such as institute website notification and Notice Board of Institute.
2. The admission should be granted as per following priority in order of merit.
  - i) The first priority should be given to GATE/GPAT qualified candidates whose names appear in the ACPC merit list.
  - ii) The second priority should be given to Non GATE/Non GPAT candidates who have appeared in PG CET 2014 conducted by ACPC and their names appear in ACPC merit list.
3. The above process shall have to be completed by 31-8-2014 and the institute has to submit the admitted list of candidates for endorsement by the ACPC with the following documents latest by 1.9.2014
  - a) Copy of Advertisement published in news-papers with the bill of Advertisement or copy of website notification.
  - b) Copies of Application forms of candidates issued and received at institute with its register
  - c) Inter-se merit list
  - d) Copy of attendance register
  - e) Admitted list of students.
  - f) Copies of Fees received of admitted candidates by the Institute
4. The entire admission procedure is to be conducted as per Education department Notification No.GH/SH/37/2013/PVS/102013/404/S dt. 26-6-2013 available on this committee's website.

The vacant seats are to be filled strictly as per above procedure. Further the entire process has to be carried out in highly transparent manner, the responsibility of the same will lie with the Principal of concerned institute.
